# TEEKANNE WELLNESS WEEKEND IN LAS VEGAS WITH STEFFI GRAF SWEEPSTAKES OFFICIAL RULES

### 1. Eligibility

TEEKANNE Wellness Weekend in Las Vegas with Steffi Graf (the "Promotion") is open only to legal residents of the fifty (50) United States (including District of Columbia) who are at least eighteen (18) years old at the time of entry. Void in Guam, Puerto Rico, the U.S. Virgin Islands, and other U.S. territories and possessions and where prohibited by law. Employees of Redco Foods, Inc. or any of its respective affiliates, subsidiaries, advertising agencies, or any other company or individual involved with the design, production execution or distribution of the Promotion and their immediate family (spouse, parents and step-parents, siblings and step-siblings, and children and step-children) and household members (people who share the same residence at least three (3) months out of the year) of each such employee are not eligible. The Promotion is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein. The Promotion consists of a sweepstakes (the "Sweepstakes").

### 2. Sponsor

### 3. Timing

Promotion begins on September 17, 2009 at 6:00 a.m. Eastern Time ("ET") and ends on March 31, 2010 at 12:00 p.m. ET (the "Promotion Period"). Sponsor is the official time keeper for this Promotion.

### 4. How to Enter

There are two ways to enter during the Promotion Period: **1)** Visit [www.teekanne.us.com](http://www.teekanne.us.com), fill out the online entry form completely by providing your name, address, phone number, date of birth and gender, and submit the form; or **2)** Enter by following the instructions found in participating stores on shipper displays containing packaging of TEEKANNE Herbal Wellness Tea boxes. Hand print your first and last name, phone number, email address, date of birth, street address, city, state and zip code on a 3" x 5" piece of paper or entry form found in participating stores and mail it with proper postage to TEEKANNE Sweepstakes Department,

All entries become the exclusive property of Sponsor, and will not be acknowledged nor returned. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. You will automatically be entered with one (1) entry into the Sweepstakes. **Limit: Limit one entry per person, per household, per email address, during the Promotion Period regardless of method of entry.** Multiple participants are not permitted to share the same email address. Any attempt by any participant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that participant's plays and that participant may be disqualified. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible or misdirected registrations, which will be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the registrant or player. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winners may be required to show proof of being the authorized account holder. All entries become the sole and exclusive property of Sponsor and will not be returned. Sponsor reserves the right to contact entrants and all other individuals whose email address is submitted as part of this promotion.

#### **5. Winner Selection**

On or about April 8, 2010, Sponsor or an independent judging agency will select one (1) entry for the prize described below in Section 8 in a random drawing of all valid entries received. The entrant will be contacted using the email address, phone number or mailing address provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules.) Sponsor's decisions as to the administration and operation of the Promotion and the selection of potential winners are final and binding in all matters related to the Promotion. Winners will be notified on or about April 9, 2010. Failure to respond to the initial contact within five (5) business days of date of notification may result in disqualification.

#### **7. Verification of Potential Winners**

Potential winners must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winners will be notified by email, telephone, or mail after the date of random drawing. The potential winners will be required to sign and return to Sponsor, within ten (10) days of the date notice is sent, an affidavit of eligibility, and liability/publicity release (except where prohibited) in order to claim his/her prize if applicable. If a potential winner of any prize cannot be contacted, fails to sign and return the affidavit of eligibility and liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
